

SUMMARY ANNUAL REPORT

For NATIONAL YMCA EMPLOYEE BENEFITS PLAN AND TRUST

This is a summary of the annual report of the NATIONAL YMCA EMPLOYEE BENEFITS PLAN AND TRUST, EIN 36-3258696, Plan No.501, for period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with EyeMed Vision Care, HCC Life Insurance Company, Lincoln Life Assurance Company Of Boston, Metropolitan Life Insurance Company and United Behavioral Health d/b/a Optum to pay vision, life insurance, long-term disability, stop loss, accidental death and dismemberment and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2019 were \$3,817,451.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$40,434,732 as of December 31, 2019, compared to \$38,072,902 as of January 01, 2019. During the plan year the plan experienced an increase in its net assets of \$2,361,830. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$109,039,508, including employer contributions of \$72,751,883, employee contributions of \$31,432,397, earnings from investments of \$4,850,203, and other income of \$5,025.

Plan expenses were \$106,677,678. These expenses included \$10,035,355 in administrative expenses, and \$96,642,323 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
