SUMMARY ANNUAL REPORT

For YMCA EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the YMCA EMPLOYEE BENEFITS PLAN, EIN 36-3258696, Plan No. 501, for period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with EyeMed Vision Care, Lincoln National Life Insurance Company, Unimerica Insurance Company and United Behavioral Health d/b/a Optum to pay vision, life insurance, long-term disability, stop loss and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2023 were \$3,566,738.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$34,722,367 as of December 31, 2023, compared to \$26,704,569 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$8,017,798. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$100,346,551, including employer contributions of \$69,887,838, employee contributions of \$27,857,390, realized gains of \$56,107 from the sale of assets, earnings from investments of \$2,544,816, and other income of \$400.

Plan expenses were \$92,328,753. These expenses included \$9,066,326 in administrative expenses, and \$83,262,427 in benefits paid to participants and beneficiaries.
